## GBCI® CONFIRMATION OF PRIMARY OWNER'S AUTHORITY

This Confirmation shall be made part of, and subject to, the GBCI PEER Participation Agreement by and between all Owners and GBCI regarding the Project. All capitalized terms used in this Confirmation and not defined herein shall have the respective meanings ascribed in the Participation Agreement. Any attempt to modify the terms of this form may render it invalid in GBCI's sole discretion.

**1. SCOPE OF AUTHORITY.** Whereas multiple parties constitute an Owner as defined in the Participation Agreement, Co-Owner hereby confirms that the Primary Owner has been irrevocably granted authority to enter into and perform the Participation Agreement (as amended, supplemented, waived or otherwise modified from time to time by GBCI), or to designate an Agent to do so on behalf of all Owners, including Co-Owner, with Co-Owner's full knowledge and consent. Co-Owner understands that by signing this Confirmation, Co-Owner shall be bound by the actions of the Primary Owner as if the same were taken directly by Co-Owner. To the extent such actions have already been taken by the Primary Owner, Co-Owner hereby expressly ratifies such actions as having been performed on Co-Owner's behalf and thus binding on Co-Owner.
